would be good if the group could get a broader overview of the lines in the area in the

- Board Member Molloy asked for a copy of the slides for Board Members who were unable to attend the meeting, followed up on the study's that were mentioned in the slideshow and asked for a copy of them, followed up on where the results of the five year studies would be located, and about the amount of gallons that were stated to have entered Marsh Creek
- Board Member Chief Carroll asked about the acreage pumped out of Marsh Creek
- Board Member Molloy asked a question on Board Member Walker's behalf about the Boot Road Pumping Station.

- Board Member Mathis asked for clarification for the name of the company and how many companies bid on the RFP for this project

- Ginny Kerslake asked about a Right to Know Request regarding the plan. Ginny
  noted that 28,000 gallon spill number came from Attorney General Shapiro's
  investigation. Ginny asked Joe McGinn about what pipelines were in operation and
  what Energy Transfer's role in the MOCC 2 hydrogen hub application. Ginny noted
  that the board should be aware of CO2 pipelines
- Board Member Nickerson went to DEP website and hasn't seen any sampling reports
  or updates on the dredging project.

Action Item: See if the reports are available somewhere through the DEP website

- Libby Madarasz noted that cleaning up the lake was very important but so is safety
  and noted the discrepancy of amount of gallons released. Libby's main concern is that
  the plan will be more of a recovery effort instead of rescue effort
- Board Member Nickerson noted that he is the emergency management coordinator in Upper Uwchlan Township and if Libby would like to go onto the township website they have information posted there
- David Shuey asked about the DEP approved additives and if any of them were in the approved mixture and what the additives were. David asked if there were any

- additives in it, would the tests pick up on them. David asked if there was some maintenance work on Mariner 1 being done and what they nature of that work is.
- Paul Kersavage noted that the PUC was in charge of the monitoring of the pipeline
   and asked if there was a contact for people to go to ask questions and get records
- Senator Muth provided information for Paul to use to help get the correct contact.
   Senator Muth noted that having all entities involved and being able to read things in advance would be helpful. Senator Muth noted that a RTK was required to get the information/data needed and is willing to share information
